APPLICATION:

The product improvement subject of this Bulletin has been cut into production as from following units:



DESCRIPTION:

- 1. The installation of the optional parcel rack doors on C2000 Series coaches has been changed to provide improved retention. The new doors feature a redesigned and relocated gas strut mounting bracket and a larger ABS liner with a glued-in aluminum back-up plate to accept the mounting screws (see Figures 1).
- 2. In the interest of improved service life, the procedure in this Bulletin shows a revised installation method for old-style parcel rack doors, fitted to coaches in the field.



PROCEDURE:

- 1. General:
 - This job should be executed by a technician experienced in body and trim repair

2. Special tools, equipment or services:

 This job requires the use of a 5/16 inch (8 mm) drill bit with a flat washer brazed on the body, ½ inch (13 mm) from the tip, to provide a positive stop and ensure a fixed drill depth (VH 313080039).

3. Preparations:

• Park the coach on a level surface with the front wheels straight. Apply the parking brake and shut down the engine.


- Switch off all systems and turn off the battery master switch.
- Put a "DO NOT OPERATE" tag on the instrument panel.
- Read the entire procedure before beginning to work.

<u>CAUTION</u>: Observe safe shop practices at all times.

4. To change the gas strut upper mounting bracket installation:

Job time estimate: modifying the parcel rack doors of one vehicle takes approximately 1 hour.

- 1) Open the parcel rack door.
- 2) Undo and remove the two self-tapping screws securing the gas strut upper mounting bracket to the door.
- 3) Line-up the gas strut and mounting bracket so that they are parallel to the parcel rack post (see Figure 3). Make sure that the bracket is at the same distance from the long side of the door as per factory installation (see Figure 4). The bracket holes should match the screw holes.



- 4) If the bracket holes do not match the screw holes, mark the new position of bracket holes on the ABS liner with a prick punch.
- 5) Drill two 5/16 inch (8 mm) holes to accept the self-tapping nuts VH 10611107.
- 6) Install the self-tapping nuts. Secure hand tight.

<u>CAUTION</u>: Do not over-tighten the self-tapping nuts. Over-tightening will render the mounting holes useless.

- 7) Reinstall the gas strut mounting bracket with bolts VH 660284921 and lock washers VH 660636200. It may be necessary to remove some of the liner material to make the bracket base meet the panel dead flat. Tighten to a torque of 3 ft.lbf (4 Nm).
- 8) Check parcel rack door operation.
