Chapter 3 : Drive train

• Section 3.1A: The procedure for draining and changing the fuel filter on Cummins engines has been revised (Page 3.1A-10).

Chapter 4: Axles, wheels and tires

- Section 4.1: The wheel alignment specifications have been revised (page 4.1-1).
- Section 4.2: Wheel alignment data have been added (page 4.2-1).
- Section 4.3: The wheel alignment specifications have been revised (page 4.3-1).

Chapter 5 : Brakes


